Woodline Partners LP (“Woodline”) understands that visitors to this website are concerned about the privacy of their Personal Data (i.e., information related to a specific individual). This Privacy Policy describes how Woodline collects, uses, discloses, and otherwise processes the Personal Data we collect through online and offline interactions, including on our website at www.woodlinepartners.com, and the rights you may have with respect to that information.

This Privacy Policy does not apply to information that we collect in the context of providing financial services to US-based individuals, such as investment advice, which is instead described in our GLBA Notice. Please contact us at compliance@woodlinepartners.com to request a copy.

INFORMATION COLLECTION

Sources of Personal Data

We collect Personal Data from the following sources:

- **Directly from you** when you choose to share it with us. This may include when you visit our website, request information from us, or contact us.
- **Third parties** such as service providers, recruiting agencies, business partners, and our affiliated companies and subsidiaries.
- **Publicly available sources** such as public profiles and websites.

We may combine information that we receive from the various sources described in this Privacy Policy, including third party sources, and use or disclose the combined information for the purposes identified below.

Types of Personal Data Collected

The Personal Data we collect may include:

- **Identifiers**, such as your name, address, email address, telephone or mobile number, device identifiers (e.g., IP address), Woodline account number;
- **Records about you**, such as signatures, physical characteristics or a description of you, and the content, timing, and method of communications you have with us, such as online chats, calls, and emails;
- **Demographic information**, such as age and gender;



Internet or other electronic network activity information, such as information about how you use and interact with our websites, information about your device, and internet usage information.

- **Non-precise geolocation data**, such as your location as derived from your IP address and company sponsored mobile applications;
- **Professional or employment related information**, including employer-related information, such as your role or title and the company's name, address, and phone number; and for prospective employees and job applicants, career information such as industry, years of experience, and skills, interests such as locations interested in working, work area of interest, and interest in upcoming events, and education information, such as educational history and expected date of graduation for current students;
- **Audio, electronic, visual, or other sensory information**, such as photographs and audio/video recordings prospective employees and job applicants may choose to submit to us;
- **Inferences** drawn from any of the information we collect that may reflect your preferences, characteristics, predispositions, behavior, interests, attitudes, or similar behavioral information; and
- **Sensitive Personal Data**, including application portal password and username for prospective employees and job applicants.

INFORMATION USE

Woodline may use the Personal Data we collect from and about you for any of the following purposes:

- To deliver our services;
- For recruiting, position advertising, talent management, and employment purposes;
- To market to you and send you information, newsletters, and other materials from Woodline (with your consent as required by applicable law);
- To contact you when necessary, including for employment purposes and to respond to your inquiries, by email, telephone, text message, or mail (with your consent where required by applicable law);
- For our internal business purposes, such as maintaining business records, performing accounting and document management activities, and IT security and administration;
- For our internal research and improvement purposes, such as designing and improving our services, developing and improving algorithms, artificial intelligence or machine learning tools and models, evaluating the effectiveness of our advertising or marketing efforts, and debugging and repairing errors with our systems, networks, and equipment.



- In connection with a corporate transaction, such as if we acquire assets of another business, or sell or transfer all or a portion of our business or assets including through a sale in connection with bankruptcy and other forms of corporate change.
- To protect the security or integrity of our business, such as by protecting against and preventing fraud, unauthorized transactions, claims and other liabilities, and managing risk exposure, including by identifying potential hackers and other unauthorized users;
- For legal reasons, such as complying with legal, reporting, and similar requirements; investigating and responding to claims against us, our personnel, and our clients, and for the establishment, exercise, or defense of legal claims; and
- As otherwise described to you at the point of data collection.

We may use anonymized, de-identified, or aggregated information for any purpose permitted by law.

INFORMATION DISCLOSURE

We may disclose Personal Data to the following categories of third parties:

- With our affiliates and subsidiaries;
- With our third-party service providers that provide business, professional or technical support functions for us;
- With professional consultants such as accountants and lawyers;
- As necessary if we believe that there has been a violation of our rights or the rights of any third party or to enforce our terms and other agreements or policies;
- To respond to judicial processes or provide information to law enforcement or regulatory agencies or in connection with an investigation on matters related to public safety, as permitted by law, or otherwise as required by law; and
- As otherwise described to you at the point of collection.

We may share your Personal Data in connection with a merger, financing, acquisition, dissolution transaction, bankruptcy or proceeding involving sale, transfer, divestiture of all or a portion of our business or assets. If another entity acquires our business or assets, that entity will have your Personal Data collected by us and will assume the rights and obligations regarding your information as allowed by this privacy policy.

DATA AND NETWORK SECURITY

We maintain security, including physical, electronic, and procedural protections, to safeguard our data networks and help prevent the unauthorized access to data we may collect. Although we maintain reasonable security safeguards, no security measures or communications over the Internet can be 100% secure, and we cannot guarantee the security of your information.



Your Personal Data will be retained as long as necessary to fulfill the purposes we have outlined above unless we are required to do otherwise by applicable law. We consider those purposes, our legal requirements, and the sensitivity of the data to help us determine how long we will retain it.

- **Right to Know.** You may have the right to request information about the categories of Personal Data we have collected about you, the categories of sources from which we collected the Personal Data, the purposes for collecting, selling, or sharing the Personal Data, and to whom we have disclosed your Personal Data and why. You may also request the specific pieces of Personal Data we have collected about you.
- **Right to Delete.** You may have the right to request that we delete Personal Data that we have collected about you.
- **Right to Correct.** You may have the right to request that we correct inaccurate Personal Data that we maintain about you.



- **Right to Limit Use and Disclosure of Sensitive Personal Data.** You may have the right to limit the use and disclosure of Sensitive Personal Data. As described below, we do not use or disclose Sensitive Personal Data in ways that would require us to provide a right to limit.

We will not retaliate against you for exercising your privacy rights.

Verification: To process your rights request, we collect information necessary to verify your identity and that you are a resident of California, such as name, mailing address, email address, phone number, relationship to Woodline partners.

Your Data Protection Rights: You may exercise certain rights regarding your Personal Data.

- **Right to Access.** You may have the right to obtain confirmation from us whether we are processing your Personal Data and a copy of your Personal Data.
- **Right to Data Portability.** You may have the right to your Personal Data be provided to you in a structured, commonly used, and machine-readable format.
- **Right to Rectification.** You may have the right to request that we rectify inaccurate Personal Data and complete incomplete data.
- **Right to Objection.** You may have the right to object to the processing of your Personal Data in certain cases.



- **Right to Restrict Processing.** You may request that we restrict the processing of your Personal Data in certain cases.
- **Right to Erasure.** You may request that we erase your Personal Data in certain cases.
- **Right to Refuse or Withdraw Consent.** In case we ask for your consent to process your Personal Data, you are free to refuse to give it. If you have given your consent, you may withdraw it at any time without any adverse consequences. The withdrawal of your consent will not affect the lawfulness of any processing of your Personal Data that occurred prior to your withdrawal.
- **Right to Not Be Subject to Automated Decision-making.** You have the right not to be subject to a decision based solely on automated processing and to be given more information about why any such decision was made.

If you are not satisfied with our response, you have the right to lodge a complaint with a supervisory authority in the country where you reside or where the conduct that is the subject of the complaint occurred.

International Transfers of Personal Data: Due to the global nature of our operations, some of the recipients mentioned in the DATA DISCLOSURE section of this Privacy Policy may be in countries outside the UK that do not provide an adequate level of data protection as defined by data protection laws in the UK. Transfers within our corporate group or to third parties located in third countries that have not received such recognition take place using an acceptable data transfer mechanism, such as the UK Standard Contractual Clauses.
